As per articles 11 and 13 of the Law on Personal Data Protection No. 6698 ("Law") and article 5 of the Communique on the Procedures and Principles for Applying to Data Controller, data subjects are granted some right in relation to processing personal data. Within this scope, you have a right to learn whether your personal data are processed or not, to request information if your personal data are processed, to learn the purpose of your data processing and whether this data is used for intended purposes, to know the third parties to whom your personal data is transferred in the country or abroad, to request the rectification of the incomplete or inaccurate data, if any, and to request to inform the third parties of this rectification to whom your personal data is transferred, to request the erasure or destruction of your personal data under the conditions laid down in Article 7 except for legal boundaries, to object to the processing, exclusively by automatic means, of your personal data, which leads to an unfavorable consequence for the data subject, to request compensation for the damage arising from the unlawful processing of your personal data.

As per article 13 of the Law, you have to send our Company your requests in relation to such rights in writing or through other methods determined by the Personal Data Protection Board.

Within this framework, you may forward your applications, which have to be made in writing, to us by using this from;

- a. Upon the personal application of the Applicant,
- b. Through Notary,
- c. By signing with "safe electronic signature" of the Applicant defined under the Law on Electronic Signature No. 5070 and sending to the registered electronic mail address of the Company.

In order for a person apart from data subject to make a request, a special power of attorney, which is entrusted by data subject on behalf of applicant in relation to the request matter, must be provided.

In order for your requests to be concluded properly and in the quickest way, it is necessary to fill the information set forth herein completely.

Your request shall be finalized within the shortest period and within thirty days at the latest in any event. Our responses shall be sent to you through the method that you have chosen above.

In case the information that you provide within the scope of the form in relation to your request is not accurate and updated, or an unauthorized application is made, our Company shall not be responsible for such cases.
